

The athlete's underlying health condition as stated on this form and the resulting impairment must fully explain the loss of function exhibited by the athlete during athlete evaluation. Otherwise, no sport class can be allocated by the classification panel, as stipulated in the International Wheelchair Fencing sport's classification rules.

Therefore, additional, recent (not older than 12 months), and relevant medical documentation must be included separately, in typed English in headed official clinic/hospital paper with this form if the athlete has the following\*:

- an impairment or diagnosis that cannot be ascertained by clear signs and symptoms.
- a complex or rare health condition, or multiple impairments.
- limb deficiency or leg length difference (amputation or dysmelia) at the level of an ankle, knee, wrist or elbow joint (X-rays for the respective joints to be enclosed).
- a spinal cord injury (recent ASIA scale results to be enclosed).
- one of the coordination related impairments Motor Ataxia, Dyskinesia (athetosis, dystonia, chorea) or Hypertonia/Spasticity (Australian Spasticity Assessment Scale scores to be enclosed).

Reports on additional testing by physicians, physiotherapists, and other health professionals are welcomed, where relevant, to complement the medical diagnostic information in an English translated typed version.

The Wheelchair Fencing International Classification panel may ask for further information to be submitted depending on the individual athlete's health condition and impairment.

*\*Athletes and NPCs/NFs are advised to observe the Eligible Impairments defined in the International Wheelchair Fencing Sport's classification rules, as not all the impairments mentioned above are considered Eligible Impairments in all sports.*

## International Wheelchair Fencing Athlete Evaluation Consent Form

1. I agree to undergo the Athlete Evaluation process detailed in the Wheelchair Fencing Classification Rules and administered by a designated International Wheelchair Fencing Classification Panel. I understand that this process may require me to participate in sport-like exercises and activities which may include me being observed whilst competing. I understand that there is a risk of injury in participating in exercises and activities. I confirm that that I am healthy enough to participate in the Athlete Evaluation.
2. I understand that I must comply with the requests made by the Classification Panel. This includes providing sufficient documentation to allow an international Classification Panel to determine whether I comply with the eligibility requirements for international Wheelchair Fencing. I understand that if I fail to comply with any such request then Athlete Evaluation may be suspended without a sport class being allocated.
3. I understand that Athlete Evaluation requires me to give my best effort, and that any Intentional Misrepresentation of my skills, abilities and/ or the degree of my Impairment during Athlete Evaluation may result in me facing disciplinary action from World Abilitysport.
4. I understand that Athlete Evaluation is a judgment process, and I agree to abide by the judgment of the international Classification Panel. If I do not agree with the decision of the international Classification Panel, I agree to abide by the Protest process as defined in the classification rules.
5. I agree to be videotaped and photographed during the Athlete Evaluation process and that this may include my activity on and off the field of play during the Competition.
6. I agree and consent to World Abilitysport processing my personal data in any format, including my full name, country, date of birth, sport, sport class, sport class status, and relevant medical information. I agree and consent to my name, country, and sport class and sport class status being published by World Abilitysport and IWF and shared with third parties such as Competition Organisers.

**Submission Process:** Once you have uploaded your athlete's medical documentation to the WA-SMS, you must email [classification@worldparafencing.org](mailto:classification@worldparafencing.org) to confirm.

**Assessment Dates:** Classification reassessments will take place on 17 and 18 February 2026, before the World Cup.

**Mandatory Attendance:** Athletes applying for reassessment must be available from the morning of 17 February 2026.

**Paper copies will not be accepted upon arrival – all documentation must be submitted in advance via WA-SMS.**

**Late entries for the competition are not eligible to be seen for reassessment and will not be considered.**

The Head of Delegation Meeting will be held on **18. FEBRUARY 2026 at 9.00pm** at the AC Hotel (meeting room).

## **NEUTRAL PARA ATHLETES (NPA)**

As payment in lieu of the obligation to provide referees, a fee of 150 GBP will be charged per Neutral Para Athlete (NPA) entered, per competition entered (see "Neutral Athlete and Support Personnel Regulations" from 28 March 2024).

### DEADLINE: 8 JANUARY 2026

Remark: The Accreditation Rates and Room Rates do not include the World Abilitysport fee of £50 for each participant (athlete, official, staff, ...) which will be invoiced and has to be paid to World Abilitysport after the competition.

The data from Entry Forms and Ophardt system must be consistent and current!

It is responsibility of the national federations to inform World Abilitysport and the local Organizing Committee about any changes and keep all data up-to-date.

Invoices for entered participants (Accreditation Rates and Room Rates) will be sent once you have completed the booking section and has to be paid directly to the LOC using the bank details below.

### TRANSPORTATION

The Room Rate fee includes the transfer from/to the Pisa International Airport.  
The fee for Transportation from/to the Florence airport / Pisa is 90 Euro per person, one way.  
Transportation **from/to other Italian airports** has to be discussed with the LOC.

The requests for transportation will be accepted **BEFORE 18 JANUARY 2026**.  
Transfers requested after this date are not guaranteed

### PAYMENTS FOR ACCREDITATION, ROOM RATES AND TRANSPORTATION

The Accreditation Rate will allow competition accreditation only (airport transfers, travel to venue, accommodation and food is NOT included).

The Room Rates will include accommodation and food in the official Hotels, airport transfers to the hotels and between the hotels and the venue.

Day rates start from the dinner on the day of arrival and continues until breakfast on the day of departure.

## LATE ENTRIES / REGISTRATIONS

In exceptional situations of

- the registration of accommodation packages with the local organizers after **8 January 2026**
- the registration of athletes and officials in Ophardt system after **8 January 2026** may be considered by LOC and World Abilitysport, and may be accepted.

In this case a 20% penalty fee will be added to Accreditation Rates and Room Rates by the local organizers, and World Abilitysport will charge a £150 (after **16 February 2026**: £250) late entry surcharge for each late entry.

## CANCELLATION POLICY

Cancellations after the closing deadline for entries are only possible for medical reasons or force majeure, which have to be proved. The national federation must inform World Abilitysport **and** the local organizers.

Any cancellation of ordered accommodation packages **after 9 January 2026 but before 1 February 2026** will result in applying the cancellation fee:  
**50% of packages that have been ordered and cancelled.**

Any cancellation of ordered accommodation packages **after 1 February 2026 but before 14 February 2026** will result in applying the cancellation fee:  
**75% of package that have been ordered and cancelled.**

Any cancellation of ordered accommodation packages **after 15 February 2026** will result in applying the cancellation fee:  
**100% of package that have been ordered and cancelled.**

## WORLD ABILITYSPORT FEES

The **World Para Fencing IF Fee** (50 GBP per person), a possible **Late Entry Surcharge** (150 GBP per person after the entry deadline and until 3 days before the competition, 250 GBP until the head of delegation meeting), the **fine for missing referees** (1.500 GBP per missing referee before and 2.000 GBP after the entry deadline) and possible other fines must be paid directly to World Para Fencing.

Please note that all fees and penalties payable to World Para Fencing will be invoiced **AFTER THE COMPETITION**.

## START TIMES

The start times of individual and team events may be subject to change to another time on the same day after the final entry deadline, when the entry numbers of athletes and teams are known.
